

# The Theory of Evolution is a Superstitious Philosophy

According to the most widely accepted explanations of the theory of evolution, all living things is the descendant of a common single-celled "ancestor" that formed billions of years ago. The changes of the common "ancestor" that occur during their lineage are passed on to future generations. This is considered as the explanation of all life. According to them, the reason for these changes is mutations in genes, survival of living things suitable for the world environment, other non-adaptive creatures are eliminated. They explain this mechanism as natural selection.

It is a fact that it is Allah, the Lord of the worlds, who created all living things and human beings. Every thinking person immediately sees and realizes this obvious truth by examining the living things in the environment and its own body. It is very clear that the theory of evolution is an unscientific and irrational claim. It is obvious that blind coincidences cannot create an impeccable design in vitality. However, some people use the theory of evolution just to be able to deny Allah and His religion, Islam. They are trying to keep these superstitious thoughts and claims alive. For this they cling to false reasonings and claims as much as possible. They have to do this because otherwise they have to accept the existence of God. That would be self-denial for them. Therefore, the controversy on the theory of evolution still continues today.

Those who are against the Islamic faith justify themselves with word, perception and logic games. They try every possible way to get it out. However, we can only guess that they didn't believe what they claim. So it is needed to give answers to these absurd claims so that the minds of Muslims are not spoiled by these false comments and claims.

The theory of evolutions is tried to be presented as a scientific fact everywhere, up to scientific publications and in the school books used in secular education programs for about 150 years. The theory of evolution really rests on very flimsy foundations. Every claim made by evolutionists has been refuted one by one by science. On the other hand, evolutionists know very well that the facts are based on belief in Allah. But since they themselves do not believe in God and the spiritual side of man, they tried to perpetuate the materialist and atheist worldviews which are wrong and superstition. For this they cling to their views with all their own methods and stand up with false reasonings. Because otherwise they would have denied themselves. In this article, we will deal with some of the basic claims of the theory of evolution separately. We will try to prove how contradictory and false the claims are.

## The theory of evolution sees coincidences as a creative deity

Nothing in nature happens by chance. Everything is perfectly formed by a divine power. There is no place for coincidence in the universe. Everything was created with a right and wisdom. Believing in coincidences is to believe in the irregularity in the universe. If something like this happened, the universe wouldn't be able to stand, everything is stirred up to each other. But we do not see such a situation. Man sees that everything around him and in himself is moving in an orderly manner.

"We have created the heavens and the earth and all that is between the two in accordance with the requirements of truth and wisdom. The hour is surely coming. So overlook (their faults) with gracious forgiveness. Surely your Lord is the All Knowing Creator!" (Al-Hijr, 15/85)

According to the theory of evolution, unconscious, mindless, incapable and inanimate atoms like phosphorus, carbon came together as a result of coincidences. These atoms organized themselves perfectly through natural events in nature such as lightning, volcanoes, ultraviolet rays, radiation. Thus, the proteins and cells are formed. These came together again by chance, and people and all other living things were formed.

In a human DNA molecule, it exists information to fill a million encyclopedia pages. All of this information has a very important order. If we randomly sprinkle millions of letters on the street, all these scattered letters turns into a state of an article or these millions of letters are written like the ones on the newspaper

page. Is it possible to say that it was a blind coincidence? Of course not. However, according to Darwinist understanding, this extraordinary event is possible to be happened by chance.

It means that the evolutionary theorists views the chance as a creative deity. However, this is accepted by no man and no scientist.



The theory of evolution sees natural selection as evidence

The most important pillar of the theory of evolution is "natural selection". The word selection means "sorting" and "selector". Natural selection is described in the book of Darwin, "The Origin of Species", which was published in 1859. This understanding is that more populations are being produced than available resources can feed. There will be a fierce fight for life between individuals and eventually only a part of the new generation will be able to live the normal course of life. This natural selection lasts for generations. Successive generations take small steps to a change. In this process, new species are formed. The weakest of the living are dead and eliminated; survivors are the best fed and the worst protected of their enemies. According to this understanding, all living things lived in a common past. They have descended from one ancestor and are linked by a common lineage.

In a study based on the external characteristics (morphological features) of living things, they found similarities between human and ape besides being mammals. Based on these, they claimed that humans and apes descended from a common ancestor. According to them the difference between man and ape is not in nature, but only in degree.

Evolutionary theorists go even further and examine human mental characteristics and morals. They claimed that its structure was formed by a process dependent on natural selection. By this reason, evolutionists seek to find similarities between living things in order to increase their evidence. They tried to find these similarities first in the morphological structure, then in the emotions. They looked for it in expression and genetics. Thus, the biologically centered theory of evolution turned into the general theory of evolution. Thus the idea of Social Darwinism emerged.

In the researches conducted in the following years has emerged that all these views were wrong. Especially the discoveries of molecular biology after 1950, the function of DNA molecules in the cell has refuted all these claims. Because the perfectly structured information system in DNA clearly proves that his views and the results of Darwin and evolutionists are not correct.

We can give the following answers to the above claims of the theory of evolution: The mechanism expressed as natural selection does not change living things through evolution and does not give them new features. But it strengthens the traits of one specie. For example, in a region the living rabbits those who can run faster have a better chance of survival. After a few generations, the rabbits in this region consist of individuals that run faster. But never any other creature other than these rabbits, such as hounds or foxes have not evolved.


It is sometimes said that human and monkey genes are 99% similar. This is a propaganda slogan that was deliberately produced years ago. First of all, in order to compare the DNA of both species, both gene maps must be known exactly. However, so far only human genetic map is obtained. No such study has yet been done for the chimpanzee. Studies have shown that only 97 of the 30,000 genes in humans (03%) was comparable. With such scant research, establishing a lineage between human and ape is only because of the prejudices of evolutionists. It is as absurd as declaring that two thick books are 99% similar by reading only three sentences in them.

Since the genes of two living things are partially similar, the similarity rate differences shows depending on the selected genes. If dissimilar genes are selected, the result is 0%. If all is selected from similar genes, it will be 100%. Moreover, evolutionists don't compare the genesis of humans only with chimpanzees, also with the genes of fruit fly and whale. If the exact same genes are selected in a study comparing the genes of fruit fly and whale, humans will be 100% fruit flies or 100% whales. Therefore, there is no reason in claiming that 99% of all the monkey's and human genes are the same. It has no scientific or logical side.

The British science magazine New Scientist published the same issue on the Internet on September 23, 2002. In his news, with the headline "Human - Chimpanzee genetic difference tripled", he stated the following: "It has led to new comparisons between human and chimpanzee DNA. We are more unique than previously thought. For a long time, it was argued that our relatives and our genetic structure are similar to 98.5%. Now this turns out to be wrong. In reality we share less than 95% of our genetic makeup. The difference between us and chimpanzees is 3 times more than you think."

It is absurd to claim that there is a certain evolutionary origin in the behavior of animals and humans. Because these claims have nothing to do with reality. Living things don't have a mind, consciousness and ability. So it is also an absurd that they'll learn by trial and error, and then they'll register this as a behavior in their genes, and they'll transfer them to new generation. The defensive styles that save their lives, the home innate patterns of behavior such as building patterns, searching for nutritional pathways were created for them.

Allah Almighty has created every living thing with its own characteristics and behavior patterns. For example, it is not possible for a butterfly to eventually transform its body into the appearance of a dry leaf to camouflage itself to survive. And a beaver is so advanced that it cuts off the flow of water in the stream to be able to build a dam that would require engineering calculations and to have the ability to do this from the moment of birth. It is not a situation that can be explained by mechanisms. Living things were first created with certain characteristics and behaviors that they can protect themselves. They are born with these characteristics. It is Allah Who gives them these characteristics. If what evolutionary theorists claim were true, living things on earth should have emerged through gradual changes. Also over time they had to be seen to continue to change. However, the fossil record examined does not confirm this, he says the opposite. However, they are truly different creatures. They appeared suddenly, without ancestors like them, and over millions of years they have remained the same as a species without any change throughout.



# Evolutionary theorists try to explain life in terms of material elements

Darwin wrote his book "The Origin of Species" in the 19th century. In this book it was claimed that bacteria could consist of inanimate matter. This view was widely accepted in the world. Because the scientific data and the technology was not advanced enough. What is known today was unknown at that time. So it was possible to make such wrong reasonings with the knowledge of those days.

Five years after Darwin's book was published, the famous French biologist Louis Pasteur definitively refuted this belief that formed the basis of evolution. As a result of Pasteur's research, the following conclusion was reached: "Inanimate substances are definitely cannot create life." Accordingly, it is necessary to look for the cause of life in another source. This means that life on earth did not occur spontaneously, but in a miraculous and divine revealed that it began with creation. Almost all of the basic living categories known today were created 500 million years ago. It emerged simultaneously and suddenly in the geological period called the "Cambrian Age" out. Reptiles, molluscs, worms, arthropods, vertebrates they have completely different body structures in the previous geological times. These creatures had no analogues. Therefore, these creatures have appeared at a certain time simultaneously.

This fact refuted the claim that living things evolved from a single common ancestor over a long period of time and they reproduce gradually. Earth is suddenly filled with many very different creatures with body structures and extremely complex organs. It shows that living things were created by a divine power. Since evolutionists did not believe in this event, they could not explain this event at all.

It is the information in the cells that make up life. Nature, as in the example of DNA, is full of tremendous information, and since this information cannot be reduced to matter, it comes from a transcendental source. At the forefront of the theory of evolution today George C. Williams, one of its leading proponents, argues that most materialists and evolutionists do not want to see and do not accept this fact. Williams has defended materialism vigorously for years. But in a 1995 article, he expresses the error of the materialist (reductionist) approach, which assumes that everything is a matter as follows:

"Evolutionary biologists have not so far stated that they are working in two different fields. They did not notice; these two fields are matter and information... These two fields are can never be brought together with the formula we know as "reductionism". It shows that matter and information have two different domains of existence, and the origin of these two different area should also be investigated separately. Genes are more than material objects. They are packets of information... In biology, if you talk about concepts, like genes, genotypes and gene pools, you are talking about knowledge not about physical objects."

Matter and knowledge were expressed in Sufism much earlier. Ibn Arabi, His Holiness, states that every being has two faces. One of these faces is for the world. This is its substance side. The other side is oriented to Allah Almighty. We do not know this face exactly. However, this face gives us some information. This

discovery of the science of secrets was made 1000 years ago. The positive science perceive it only in the last century.

In the 20th century, science proved the fact that the information in DNA is not based on matter, as materialists claim. Therefore, the source of knowledge in nature cannot be matter, contrary to what materialists think. Source of information is not matter, but a superior intellect beyond matter. This mind exists before matter. Matter came into existence with it, was formed and organized with it. Allah is the Owner of this mind and Lord of all the worlds. This is the origin of life. This extraordinary knowledge collapses materialist philosophy. It offers numerous proofs of obvious existence of Allah Almighty.

Anthony Flew, the famous atheist philosopher, stated the following on this subject:

"I am convinced that the first living matter was made of inanimate matter by evolution, and then transformation into an extraordinarily complex creature is out of the question... DNA research by biologists, reveal the almost unbelievable complexity of necessary arrangements. It is showed that consciousness must have been at the root of life."

Professor Gerald Schroeder, one of the scientists who influenced Flew, said in his book, "Science is Absolute, Revealing the Truth":

"Intellect and knowledge manifested throughout the universe. A single consciousness, a universal mind, pervades the entire universe. The findings of science investigating the quantum nature of subatomic matter lead us to the admirable admission that the whole being is an expression of this mind. In laboratories it was first expressed as energy, then condensed in the form of matter which we observe as information. Every particle, every being, from atom to human reveals the level of knowledge and intelligence."

"The east and west belongs to Allah. Now wherever you turn, there is the Face of God. Surely, Allah is All Pervading and All Knowing." (Baccarat, 2/115)

# Evolutionary theorists cannot explain the conscious design in living things

All of the developments in the womb and after birth organized within the framework of a determined program. This is human development. The perfect arrangement is expressed in the Qur'an as follows:

"Does man, then, think that he is to be left to himself, to go about it will? Was he not once a drop of ejaculated semen which then became leechlike clot; then God shaped and fashioned him in due proportion." (Doomsday, 75/36-38)

While still in the state of a newly fertilized egg cell in the mother's womb, Allah has determined all the features which he will have in the future and it's embedded in its DNA. Eye color, blood type, face shape, bone all features, such as its structure, determined by a coded plan from nine months ago as he is only a single cell.

From the moment the egg cell is first fertilized, the growing embryo cells each of the events related to all the biochemical, physical developments that make it appear. It takes place under the control of the project in DNA. Professor Phillip E. Johnson talks about the perfection of the system as follows:

"The instructions in the fertilized egg are from the beginning of embryonic development control and ensure that it reaches a certain result. This is the complete set of instructions uses the material processes of physics and chemistry, but not produced by those processes. Likewise, software on a computer is a word operating document uses natural processes to create, but the software is created by an intelligent agent. It must be written."

It is not possible that the inanimate, unconscious atoms that make up the building blocks of the cell, do the planning, the project determining, writing, decrypting, taking multi-stage measures, to set up systems to protect the knowledge. Anyone who can think independently of materialist and Darwinist dogmas, such an order cannot come into being on its own. On the contrary, a superior mind will appreciate that. It is the work of Allah. By Allah's will, the lifeless elements in the earth combine to build a living human being and they fulfill the task assigned to them with perfect coordination.

In the Qur'an, Allah reveals:

"Who gave everything its perfect form. He originated the creation of man from clay." (Prostration, 32/7)

Dr. Lee Spetner describes the formation of a human being who can think from a single cell with these words:

"Your eyes, arms and legs, even fingernails and lashes are in perfection. This is an excellent and incredibly complex. How did living things come from a single cell? What kind of program may have led the development? Eyes that can see, ears that can hear, a brain directing the movements of its complex organs, all in one made up of cells. The fact that each of us is made up of a single cell and transforming into a thinking being that can perform many activities. It's really mind-blowing."

All these extraordinary events cannot be the work of chance or the cell itself, is clearly evident. Well, the one who manages these events in the cell has a certain purpose. Billions of information that is too small to be seen with the naked eye.

Who owns the mind and power that fits into the field? There is only one answer to this question: the Almighty Our Lord, with His infinite mercy, has created man in his present state in a proper form and offers the order in his body and around him is a blessing to man. In one verse, it is stated:

"He gave you everything you wanted. If you try to count the blessings of Allah, you can't afford to count and finish. The truth is that man is very cruel and is ungrateful." (Abraham, 14/34)

As a result, the genome (all genes) project has made no evidence in favor of the theory of evolution. On the contrary, it revealed that an evolutionary tree of life

cannot be constructed based on DNA and gene structures among living things. It dealt a great blow to Darwinism. DNA codes of living things clearly showed that the tree of life, which has been imposed on people as a truth ever since, is a superstition.

The main aim of those who are blindly devoted to Darwinism is not to provide scientific information to the public, not to convey developments, but only to spread Darwinism. However all the foundations of Darwinist propaganda is melting day by day scientifically one after another. In this situation, an increasing number of people believes that the theory of evolution is a deception perpetuated for ideological reasons and the fact of creation is spreading rapidly. Allah in the Quran states:

"Do not cover the truth with falsehood and do not hide the truth. (Besides) you know (the truth)." (Baccarat, 2/42)

"No, we throw truth over falsehood, and it smashes into his brain. And you see that it has disappeared. From what you describe against Allah woe to you for that." (The Prophets, 21/18)



# The theory of evolution tried to use fossils as evidence

As the theory of evolution puts it, if living species were to evolve over time, and they have transformed intermediate species must have formed and lived in this long transformation time. For example, besides fishes half-fish-half-reptile creatures must have lived which have some reptilian features. Some reptile also gained some bird characteristics and reptile birds must have arisen. Because they are in a transitional period, they would be crippled, deficient. They must be imperfect creatures. If indeed such creatures existed in the past their number and variety must have been in the millions. In this case, the remains of these strange creatures must be encountered in the fossil record.

Darwin explained this in his book, The Origin of Species as follows: "If my theory is correct, there are countless types of intermediates that connect species, surely they must have lived... Evidence that they lived is only can be found among the fossil remains."


From the middle of the 19th century until today, a feverish fossil studies are carried out. However, in these studies, this transition forms were not found. All the excavations and researches showed that contrary to what evolutionists expected, living things suddenly appeared on earth. It was seen that they appeared completely and flawlessly. Although the famous paleontologist (fossil scientist) Derek W. Ager is an evolutionist, he admits this fact as follows: "Our problem is this: When we examine the fossil record in detail we are constantly faced with the same reality. We do not see groups that evolve through evolution, but groups that suddenly form on the earth."

Fossils show that living things emerged in a complete and perfect form on earth. So the origin of species, contrary to what Darwin thought, is Creation, not evolution. There are also some fossil records that disappoint evolutionists on this subject.

Evolutionists claimed the Coelacanth class to be an intermediate form whose fossils are 400 million years old, between fish and amphibians (livings that can live both on land and in the sea). They thought it as a very strong intermediate form evidence and this specie was exhausted 70 million years ago. They made all kinds of speculations on it. But in 1938 the Indian Ocean a Coelacanth was found alive off the coast. In the following years, other more than 200 were caught in the regions.

With the catching of these fish, the groundlessness of the speculations was also understood. Coelacanth, contrary to the claims of evolutionists, has not halffish, half-amphibian features. Even above a depth of 180 meters they don't live. It was a bottom fish that didn't come out. Moreover, between living Coelacanths and 400-million-year-old fossils there was no difference. In other words, the living thing had not undergone any evolution. That is it is a fish that disappoints evolutionists.

Likewise, the 150-million-year-old bird fossil called "Archaeopteryx", it has been cited as the "greatest fossil evidence of evolution" since the 19th century. This bird shows some reptilian characteristics and therefore claimed to be the missing link between reptiles and birds. However, recent findings showing that a complete Archeopteryx is a flying bird have invalidated this claim. Moreover, theropod dinosaurs, considered the so-called reptilian ancestors of birds are much younger than Archeopteryx. This is the fact what evolutionists try to hide.



Miracles in DNA molecules invalidate the theory of evolution

The DNA in the cell nucleus has a helical structure. This spiral structure when opened, the DNA becomes a long strand of string about 4 meters long. DNA is found inside chromosomes. Thickness of chromosome is 1 nanometer that is one billionth of a meter. The DNA helix is a very smoothly rotating and resembles a ladder. The strips are composed of sugar and phosphate and steps between them are a special sequence of amino acids.

DNA strands contain all kinds of proteins, enzymes, molecular information needed to build engines, hormones, and other building blocks. This coded information determines that the eyes, ears are symmetrical, the heart is blood pumping, carrying oxygen to cells, breaking down nutrients formation of stomach acid and all other physical properties of the body. The information packages that determine these are called genes. According to this DNA is a molecule specially created to store information. It is impossible for this structure to come into existence by chance. It has come into being consciously by the command and knowledge of Allah.

"Such is God your Lord: to Him belongs all dominion. And those whom you invoke besides Him have not the least power." (Fatir, 35/13)

Professor Werner Gitt says the following about the special structure in DNA: "The encryption system used for living things is the best from an engineering point of view. It is perfect. This fact shows that it is a purposeful creation rather than coincidental coincidences. It reinforces this view."

Inside DNA is a huge data bank equivalent to tens of thousands of volumes of books. According to Darwinists, this data bank came into being spontaneously by chance. It was compressed into an invisible dimension by chance. Evolution theorists blindly defend such an impossibility.

However, neither the cell nor its data bank, DNA, is the accidental creation of unconscious atoms. It cannot be formed by their coming together. Even the smallest parts of living things were created with a purpose, and each of them has a complex structure so that it will not allow for coincidence. This is now the case for almost everyone. The German philosopher Arthur Schopenhauer says: "...The organism is alive in all its parts, and they are nowhere - the smallest even its particles – not just a collection of inanimate matter."

Claiming that DNA and the vast information it contains came into being by itself is a serious mental breakdown. Among those running the human genome project Gene Myers stated the following about the information in DNA: "We also don't understand yet...there is a metaphysical, supernatural element, really the architecture of life astonishing... The system is incredibly complex...There is a tremendous mind here (in the DNA). I do not believe that it's unscientific for me to think that way. Others may think so, but not me." This inexplicable but admirable intelligence and knowledge in DNA is a reflection of infinite wisdom and knowledge of Allah.


"Allah is the light of the heavens and the earth. The representation of His light is a candle in which there is a lamp. That lamb is in a crystal; it's crystal like a star like a pearl. He is ignited by oil which comes out of a blessed tree that cannot be compared to the east or the west. This is such a tree that even gives light, its oil is almost untouched by fire. Light upon Light. Allah guides whom He wills to His light. This is how Allah sets an example for people. God knows everything." (Light, 24/35)

All living things on earth, bacteria, viruses, insects, horses and plants have their own DNA in their cells. In the DNA of each information, the detailed plan of the organism's own body structure and its needs. Considering that there are millions of living species on earth, the amount and scope of this information will be better understood.

It is Allah Who creates separate DNA sequences for different species. From the moment when life was first created, the whole body has been inside the cells for a lifetime. This wealth of information, which guides its activities, has been placed. It is not a slow and gradual development process as evolution theorists claim. Because, if even one of the information is missing, it is impossible for that creature to reproduce and live.

In this case, the claims of evolutists that the cells of living things pass through long and gradual periods, is completely irrational.

"...when He created you from soil, and you were in the wombs of your mothers. He knows you best while you are there. Don't justify yourself for this. For He knows best who refrains from evil." (Stars, 53/32)



## Cell mutations are not evidence for the theory of evolution

Neo Darwinism is an effort to hold on by combining with Darwin's theory of evolution and Austrian biologist Gregor Mendel's laws of genetic inheritance. Neo Darwinists, like Darwin, argue that the diversity in life occurs spontaneously and is accidental. They cited genetic changes as the source of life during the copying of DNA by external effects such as radiation in genes or that may occur during very small changes (mutation).

For their theories, they thought, they could use it. They claimed these small changes eventually would cause big changes. However, this understanding is invalid. Because for today, many scientists accept the level of complexity in life cannot be obtained by what Neo Darwinism assumes. Professor Marcel Paul Schützenberger, in his book "The Mathematical Challenge to the Neo Darwinian Interpretation of Evolution" says: "We believe that there is a serious gap in the theory of evolution of Neo-Darwinism. And We believe that this gap is of such a nature that it cannot be filled by today's concept of biology."

Any explanation that the theory of evolution tries to bring about the origin of life are irrational and unscientific claims. In this regard, Professor Pierre Grassé says:

"Meeting the needs of animals and plants through random mutations. It's really hard to believe it does. But Darwinism goes more than and wants that a single plant, a single animal, thousands and thousands of exactly what it should be exposed to beneficial coincidences. So miracles are a common rule for events with incredibly low probabilities should easily become should happen. There is no law forbidding daydreaming, but it should not be included in science."


Because mutations occur randomly, they almost always do harm for living things. Any unconscious intervention to a complex structure does not take the structure further, on the contrary, it destroys it. Indeed, there is no valid example of random beneficial mutations proposed as the mechanism of evolution.

Can new knowledge be formed as a result of mutations? Professor Werner Gitt answers as follows: "This view is based on evolutionist accounts, but mutations may cause the existed information to be changed. There can be no increase in this knowledge and in general the results are harmful. New functions or new organs cannot occur; mutations cannot be the source of new (creative) knowledge."

How random mutations negatively affect the information and order in DNA is explained by Professor Phillip Johnson as follows: "...random mutation is not such a mechanism, natural selection and physics or as well as the laws of chemistry. Laws produce simple repetitive patterns, coincidence produces meaningless order. When law and coincidence meet, preventing a meaningful sequence both work against the other. Of all human experience, only intelligence factor can write an encyclopedia or computer program and can produce complex, specialized and non-periodic information. Therefore, in organisms necessarily found knowledge indicates that they are products of creation."

All this shows that, as evolutionists claim, the origin of living things is random mutations have no place. Mutations cannot be the cause of diversity by no means in living things. Proteins are the most important building blocks of living things. For protein synthesis in the cell structure, hundreds of different proteins and enzymes are needed. How did the first protein appear out? This question is one of evolutionists' most important dilemmas. In this respect the evolutionist biologist Carly P. Haskings states the following in an article: "... But thanks to biochemical genetics, many important questions of evolution still could not be answered... In all living things, both DNA replication and translating the codes on them into proteins is possible only by quite specific and convenient enzymes. At the same time, the structures of these enzyme molecules is determined by DNA itself. This truth raises a problem very mysterious in evolution. In the case of evolution did the code itself and this other enzymes required in the synthesis of proteins come together? The extraordinary complexity of these compounds and uninterrupted coordination between them for their synthesis. It's ridiculous to talk about the time congruent. We should seek the answering this question outside of Darwin's views. Because the situation in question constitutes a very strong piece of evidence that predicts special creation."

According to this explanation, for protein synthesis to occur, all the systems must exist together. Evolutionists claim the coincidence of these proteins and then the cells formed by the accidental assembly of proteins. This is an expression of the collapse of the theory of evolution. Because today we know that without one of these parts, the other is absolutely does not occur. This tells us that all living beings is created by Allah together with all their systems. This means quadrillion communications simultaneously. On the other hand transistors in computers which are the nerve cells of computer, have only 6 ports. The world's fastest processing computers can process on average 10EXP9 per second. The speed of the brain is 10EXP15 for the same process. Moreover while the capacity of computer memory is 10EXP11 bits (bit=computer saveable smallest unit of information) brain is 10EXP14. This difference shows that its capacity is as much as the total capacity of 1000 computers.

It is absolutely impossible for cells that the coincidence organize nerve-wracking to form an admirable network. How come the internet technology or even the simplest telephone exchange by chance? It is clear that it is necessary engineering, design, knowledge, intelligence and technology for this. How people who know that the more extraordinary system in the brain can claim to have occurred accidentally? Undoubtedly, it is the result of commitment blindly apply to the theory of evolution. Every person who approaches without prejudice, can see the magnificence in creation.

Some microbes and foreign substances called antigens enter the circulatory system and they pose a danger to humans. The defense system cells try to destroy antigens by producing substances called antibodies. They try to prevent their reproduction. But the interesting thing is that artificial antigens created in the laboratory and placed in the human body are detected by antibodies. Blood clot is similar with emergency calls to an accident on the highway. It is a process reminiscent of the first aid of patrols and ambulances. When there is bleeding in any part of the body, the first aid is called platelet, comes from blood plaques. Platelets circulate dispersedly in the blood. For this reason, wherever the bleeding is in the body, there is a patrolling platelet close to that area.

A protein named "Von Willebrand" helps by pointing to the accident site. When he sees the platelets like a traffic policeman who wants to, he cuts them off and allows them to stay in place. The first platelet arriving at the scene secretes a substance and calls the others to the scene. Meanwhile, twenty enzymes in the body come together and act on the wound. It begins to produce a protein called thrombin. Thrombin is produced only on open wound. The medicine required for the patient by the first aid team at this crime scene. It's like making it on the spot. Moreover, this production is exactly as needed. In addition, this protein production must start at the right time and at the right time must be stopped. The enzymes that produce this protein give the start and stop command between them.

After sufficient amount of thrombin protein is produced, strands are formed. It is called fibrinogen. These filaments form a web over the blood and incoming platelets accumulate by attaching to this network. When this accumulation is concentrated, the blood outflow stops. The enzymes and proteins mentioned here are structures made up of different arrangement of atoms which are lifeless, unconscious blind. Each of these the most urgent form of injury, by undertaking a duty from the very beginning of the injury, flowing in the province they organize to stop the blood. 
Blood is like a garbage unit that collects cell waste. It carries waste materials to the kidneys and these substances are cleared in the kidneys. Toxic produced in

A team in the stomach is in delicate balance. While cells secrete acid, other cells next to these cells also secretes a sticky liquid. Although the researcher Lord Solly Zuckerman who is an evolutionist, came to the conclusion that there is no real family tree from ape-like creature to human. 
